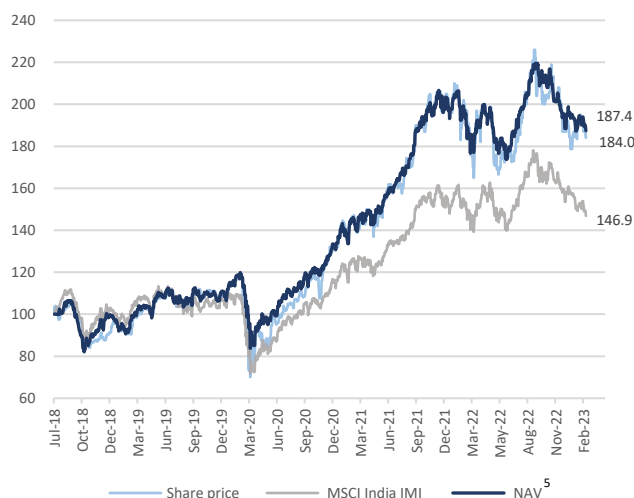

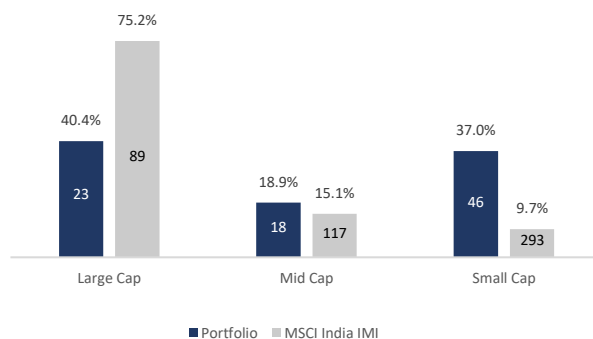

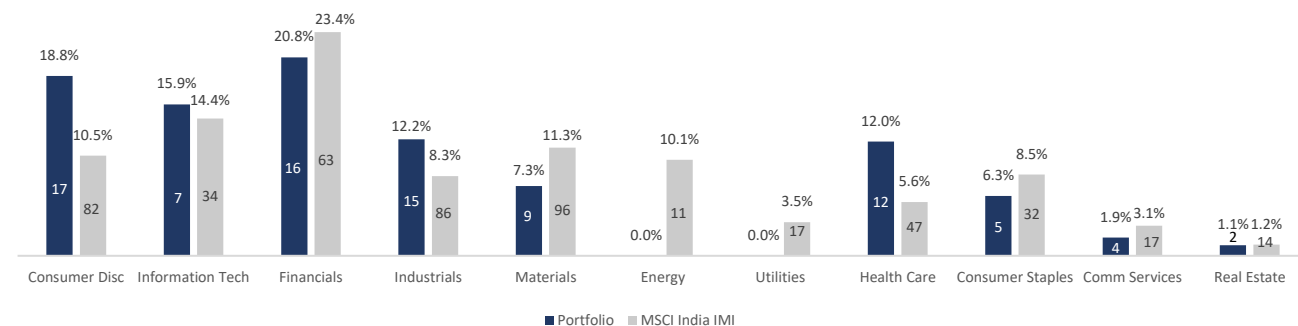

Market Review

In Feb 2023, the MSCI India IMI index was down 2.6%. It outperformed MSCI EM, which was down 4.7% but underperformed other global indices like US equities (S&P 500) and MSCI World, which were down 0.7% and 0.6%, respectively.

Foreign Institutional investors (FIIs) were net sellers to the tune of US\$0.1bn, while net buying by domestic institutional investors (DIIs) was US\$2.3bn. For the month, the Rupee appreciated by 1.3% vs the GBP while the 10-year G-Sec yields inched up from 7.34% to 7.43%. Commodities were weak, with Brent flat and S&P GSCI Industrial Metals Index down 6.2%.

For the month, Consumer Staples, Financials and Information Technology outperformed, while Utilities, Industrials and Communication Services underperformed. Large caps have underperformed mid and small caps this month.

Performance Review

The Fund was down 1.4% in Feb 2023, outperforming the benchmark by 119bps. The key contributors include Safari Industries (+14.5%), ABB India (+14.2%), and Kaynes Technologies (+13.0%), whereas Shaily Engineering (-27.9%), HDFC Life (-14.9%), and Ambuja Cements (-10.6%) were the key detractors.
