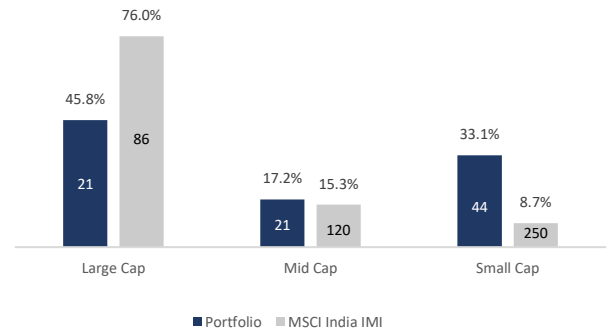

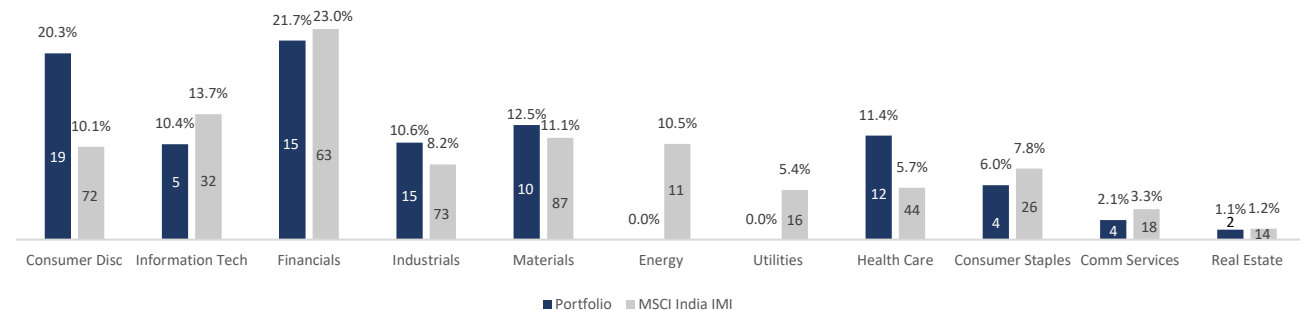

Market Review

In November, the MSCI India IMI index was up 0.2%. It underperformed global indices such as S&P 500, MSCI World Index, and MSCI EM Index, which were up 1.3%, 2.7%, and 10.3%, respectively.

Foreign Institutional investors (FIIs) were net buyers to the tune of US\$3.6bn, while net selling by domestic institutional investors (DIIs) was US\$0.8bn. For the month, the Rupee depreciated by 2.3% while the 10-year G-Sec yields softened from 7.44% to 7.28%. Commodities were mixed, with Brent down 11.6% and S&P GSCI Industrial Metals Index up 7.4%.

For the month, Energy and IT Services outperformed, while Utilities and Consumer Discretionary underperformed. On a YTD basis, Utilities and Energy have outperformed, whereas IT Services and Healthcare have underperformed.

State-owned enterprises (SOEs) have outperformed their private peers, and large caps have outperformed small caps this year.

Performance Review

The Fund was down 1.6% in November, underperforming the benchmark by 182bps. The key contributors include Bikaji Foods (+34.6%), Kaynes Technology (+15.1%), and Persistent Systems (+10.6%), whereas Campus Activewear (-23.4%), Maruti Suzuki (-7.4%), and Titan (-5.6%) were the key detractors.

Year-to-date, the fund is up 1.2%, underperforming the benchmark by 705bps. The key contributors include ICICI Bank (+34.5%), Ambuja Cements (+51.8%), and Cholamandalam Investment (+43.0%) whereas Truecaller (-67.5%), Mphasis (-40.7%), and PB Fintech (-55.5%) were the key detractors.
