

Market Review

In February, MSCI India IMI index was down 4.8%. US equities (S&P 500) were down 2.7%, MSCI World was down 2.2%, and MSCI EM was down 2.7%.

FIIs were net sellers to the tune of US\$5bn in February 2022 while net buying by local mutual funds was US\$4bn. For the month, the Rupee depreciated by 0.3% while the benchmark 10-year G-Sec yields rose from 6.7% to 6.8%. Commodities rallied, with Brent up 14% and the S&P GSCI Industrial Metals Index up by 7%.

Among sectors, materials and consumer staples outperformed, whereas communication services and financials underperformed during the month.

Performance Review

The Fund was down 5.6% in February, underperforming the benchmark by -88bps. The key contributors include Titan (+6.8%), Cholamandalam Investment (+8.9%), and Fine Organic (+10.0%) whereas Laxmi Organic (-7.3%), AGS Transact (-38.7%), and Cartrade (-26.3%) were the key detractors.

Year-to-date, the fund is down 8.6%, underperforming the benchmark by -297bps. The key contributors include Cholamandalam Investment (+32.5%), Titan (+0.5%), and Fine Oragnic (+15.0%), while key detractors were Metropolis Healthcare (-43.1%), AGS Transact (-43.3%), and Coforge (-23.1%).
