

Market Review

In July 2023, the MSCI India IMI index was up 1.9%. It underperformed other global indices like MSCI EM, US equities (S&P 500) and MSCI World, which were up 5.1%, 2.0% and 2.2% respectively.

In July 2023, foreign institutional investors (FIIs) were net buyers to the tune of US\$4.1bn, while net selling by domestic institutional investors (DIIs) was US\$0.3bn. For the month, the Rupee depreciated by 0.2% while the 10-year G-Sec yields rose marginally from 7.12% to 7.18%. Commodities rallied, with Brent and S&P GSCI Industrial Metals Index up 13.4% and 6.3%, respectively. For the month, Utilities, Energy and Real Estate outperformed, while Consumer Staples, Information Technology, and Financials underperformed. Large caps have underperformed mid and small caps this month, while State-owned entities outperformed their private peers.

Performance Review

The Fund was up 1.9% in July 2023, outperforming the benchmark by 6bps. The key contributors include Ideaforge Technology (68.1%), Dodla Dairy (+28.8%), and Kaynes Technology (+18.7%), whereas Persistent Systems (-6.3%), Safari Industries (-4.9%), and HDFC Bank (-4.4%) were the key detractors.
