



Market Review

In August 2023, the MSCI India IMI index was up 0.8%. It outperformed other global indices like MSCI EM, US equities (S&P 500) and MSCI World, which were down 4.7%, 0.1% and 0.9% respectively.

In August 2023, foreign institutional investors (FIIs) were net buyers to the tune of US\$1.4bn, while net buying by domestic institutional investors (DIIs) was US\$3.0bn. For the month, the Rupee appreciated by 0.6% vs the GBP, while the 10-year G-Sec yields remained steady at 7.16%. Commodities declined, with Brent and the S&P GSCI Industrial Metals Index down 2.2% and 2.9%, respectively.

For the month, Information Technology, Consumer Discretionary and Industrials outperformed, while Energy, Consumer Staples, and Financials underperformed. Large caps have underperformed mid and small caps this month, while State-owned entities outperformed their private peers.

Performance Review

The Fund was up 2.0% in August 2023, outperforming the benchmark by 119bps. The key contributors include Gokaldas Exports (+48.7%), Safari Industries (+29.8%), and Coforge (+17.7%), whereas Avalon Technologies (-15.4%), ICICI Bank (-2.3%), and Bajaj Finserv (-6.0%) were the key detractors.
